### NOTICE TO BIDDERS

SEALED PROPOSALS FOR SMITH FIELD PARK NEW MULTI-PURPOSE FIELD AND GENERAL PARK IMPROVEMENTS  
TOWNSHIP OF PARSIPPANY-TROY HILLS  
MORRIS COUNTY, NEW JERSEY

Sealed Proposals for the Smith Field Park New Multi-Purpose Field and General Park Improvements will be received by the Township of Parsippany-Troy Hills in the Municipal Building, 1001 Parsippany Boulevard, Parsippany, New Jersey on September ~~3~~10, 2015 at 11:00 AM prevailing time, at which time and place they will be publicly opened and read aloud. Bids must be received by the Office of the Director of Purchasing on or before the time and date of the bid opening. No bids will be accepted after said hour. Bids sent through the US Postal Service or other delivery service is done so at the bidder's own risk. All documents must be original. Facsimile or photocopies are not acceptable.

Specifications and bid proposal forms may be obtained at the Township Purchasing Office, 1001 Parsippany Boulevard, Parsippany, New Jersey, between the hours of 10:00 AM and 4:00 PM daily except Saturdays, Sundays and Holidays. Bids or proposals shall be made on the form provided.

Work consists of the furnishing of all supplies, materials and labor for the new multi-purpose field and the general park improvements located at Smith Field Park.

Major items of work are, but not limited to the following:

Synthetic grass surface multi-purpose field	113,200 SF
Underground stone bed for stormwater management	7,000 CY
Lighting for multi-purpose field	5 Units
Masonry multi-purpose building	1,650 GSF
Chain link fence	1,300 LF
Existing tennis court renovation	4 Courts
Existing basketball court renovation	2 Courts
Lighting for tennis and basketball court renovation	8 Units

The nonrefundable fee for the Plans and Specifications is \$75.00 per set. Checks are to be made payable to the Township of Parsippany-Troy Hills.

A certified check or cashier's check made payable to the Township of Parsippany-Troy Hills, or a duly executed bid bond in the amount of 10% of each bid, but in no case in excess of \$20,000.00, must be deposited by the bidder together with a Certificate of Surety evidencing that the bidder can obtain the required Performance Bond and Payment Bond in the amount of one hundred percent (100%) of the total amount of the contract.

## LEGAL NOTICE

The successful bidder shall be required to deliver to the Township an executed Performance Bond of the responsible Indemnity Company authorized to do business in the State of New Jersey.

Bidders are required to comply with requirements of N.J.S.A. 10:5-31 et seq. and N.J.A.C. 17:27. In addition bidders must also comply with the following New Jersey Statutes:

PL 1977, Chapter 33 (Statement of Ownership)  
N.J.S.A. 40A: 11-18 (American Goods and Products to be used where possible)  
N.J.S.A. 34:11-56.25 et seq. (New Jersey Prevailing Wage Act)

Bid proposal must be placed in a sealed envelope and addressed to the Office of Purchasing, Township of Parsippany-Troy Hills, 1001 Parsippany Boulevard, Parsippany, New Jersey 07054 and marked plainly on the outside with the bid description and the name and address of the bidder marked clearly on the outside of the envelope.

The Township of Parsippany-Troy Hills reserves the right to reject any and all bids or to waive any minor informalities or irregularities in the proposals received and to accept the bid which is in the best interests of the Township.
