Sealed Proposals for the **ROAD RECONSTRUCTION OF CARLSON PLACE, MANITO AVENUE, PAWNEE AVENUE & UTE AVENUE** will be received by the Township of Parsippany-Troy Hills in the Municipal Building, 1001 Parsippany Boulevard, Parsippany, New Jersey, on **Wednesday, April 30, 2014 at 11:00** AM prevailing time, at which time and place they will be publicly opened and read aloud. Bids must be received by the Office of the Director of Purchasing on or before the time and date of the bid opening. No bids will be accepted after said hour. Bids sent through the US Postal Service or other delivery service is done so at the bidder's own risk. ALL DOCUMENTS MUST BE ORIGINAL. FACSIMILE OR PHOTOCOPIES ARE NOT ACCEPTABLE.

The fee for the Plans and Specifications is \$75.00 per set. Checks are to be made payable to the Township of Parsippany-Troy Hills. Please Note: Deposit checks/cash are not refundable.

A certified check or cashier's check made payable to the Township of Parsippany-Troy Hills, or a duly executed bid bond in the amount of 10% of each bid, but in no case in excess of \$20,000.00, must be deposited by the bidder together with a Certificate of Surety evidencing that he can obtain the required Performance Bond and Payment Bond in the amount of one hundred percent (100%) of the total amount of the contract.

The successful bidder shall be required to deliver to the Township an executed Performance Bond of the responsible indemnity company authorized to do business in the State of New Jersey.

In lieu of a Certificate of Surety, the bidder shall submit, at the bid opening, a certified check or cashier's check in the amount of one hundred percentum (100%) of the total amount of the bid.

Bidders are required to comply with requirements of N.J.S.A. 10:5-31 et seq. and N.J.A.C. 17:27. In addition bidders must also comply with the following New Jersey Statutes:
