ORDINANCE NO. 2017:15

AN ORDINANCE OF THE TOWNSHIP COUNCIL OF THE TOWNSHIP OF PARSIPPANY-TROY HILLS, COUNTY OF MORRIS, STATE OF NEW JERSEY AMENDING AND SUPPLEMENTING CHAPTER 290, PARKS RECREATION AREAS AND PUBLIC LANDS, ARTICLE I, MOTOR VEHICLES; FEES, SECTION 290-4, KNOLL COUNTRY CLUB UTILITY FEES AND CHAPTER A445, FEES COMPILATION, SECTION A445-37, KNOLL COUNTRY CLUB UTILITY, OF THE CODE OF THE TOWNSHIP OF PARSIPPANY-TROY HILLS IN THE COUNTY OF MORRIS, NEW JERSEY

WHEREAS, the Township of Parsippany-Troy Hills (the "Township") wishes to update its Fees Compilation Ordinance regarding the Knoll Country Club Utility.

NOW, THEREFORE, BE IT ORDAINED by the Township Council of the Township of Parsippany-Troy Hills, Morris County, as follows:

SECTION 1. Chapter 290, Parks, Recreation Areas and Public Lands, Article I, Motor Vehicles; Fees, Section 290-4, Knoll Country Club Utility Fees, of the Township Code is hereby amended and supplemented as follows:

§290-4 A. Knoll West, Greens Fees 18 Hole Rate and Greens Fees 9 Hole Rate is hereby amended and supplemented as follows:

§290-4 C. Notes is hereby amended and supplemented as follows:

C. NOTES:

(2) All Knoll West members pay Member rates at the Knoll East.

(8) Exemptions. The following individuals or groups are exempt from the payment of Knoll Country Club Utility fees:

(a) The members of the two high school golf teams and their two coaches (one per school) for practice and the opposing team and coach for matches, provided that practices and matches are played on weekdays.

(b) The Golf Superintendent, Golf Greens Superintendent and Golf Pro are exempt from Driving Range fees.

(12) The Golf Superintendent has the discretion to reduce daily greens fee rates with approval of the Certified Financial Officer. Backup documentation required for auditors.

- (15) All member accounts with a delinquent balance as of the last day of each month will incur a finance charge of 8% per annum.

- (17) All credit card transactions will incur a convenience fee of \$3.

SECTION 2. Chapter A445, Fees Compilation, Section A445-37, Knoll Country Club Utility, of the Township Code is hereby amended and supplemented to reflect the aforementioned changes made to Chapter 290, Parks, Recreation Areas and Public Lands, Article I, Motor Vehicles; Fees, Section 290-4, Knoll Country Club Utility Fees as follows.

SECTION 3. To the extent that any previous ordinance or resolution is inconsistent herewith or contradictory hereto, said ordinance or resolution is hereby repealed or amended to the extent necessary to make it consistent herewith.

SECTION 4. If any part(s) of this ordinance shall be deemed invalid, such part(s) shall be severed and the invalidity thereby shall not affect the remaining parts of this ordinance.

SECTION 5. This Ordinance shall take effect upon passage and publication in accordance with applicable law.
