ORDINANCE NO. 2018:01

**AN ORDINANCE OF THE TOWNSHIP OF PARSIPPANY-TROY HILLS,
MORRIS COUNTY, NEW JERSEY AMENDING CHAPTER 405,
VEHICLES AND TRAFFIC, SECTION 11, STOPPING OR STANDING
PROHIBITED ON CERTAIN STREETS, OF THE CODE OF THE
TOWNSHIP OF PARSIPPANY-TROY HILLS IN THE COUNTY OF
MORRIS, NEW JERSEY**

WHEREAS, the Township of Parsippany-Troy Hills (the "Township") has the authority to prohibit or limit the stopping, standing or parking of vehicles in accordance with Title 39 of the Revised Statutes of New Jersey; and

WHEREAS, upon the recommendation of the Township Engineer and Police Department, the Township Council finds and declares that it is in the best interest of the health, safety and welfare of Township residents to prohibit stopping or standing along a section of Beachwood Road from Littleton Road (Route US 202 202) to Graham Court.

NOW THEREFORE, BE IT ORDAINED by the Township Council of the Township of Parsippany-Troy Hills, in the County of Morris and State of New Jersey, as follows:

SECTION 1. Chapter 405, Vehicles and Traffic, Section 11, Stopping or Standing Prohibited on Certain Streets, is hereby amended as follows:

Add New.

Name of Street	Sides	Hours	Location
Beachwood Road	South	All	From Littleton Road (Route US 202 202) to Graham Court

SECTION 2. If any section, paragraph, subsection, clause or provision of this Ordinance shall be declared invalid by a court of competent jurisdiction, such decision shall not affect the validity of this ordinance as a whole or any part thereof.

SECTION 3. All ordinances or parts of ordinances of the Township of Parsippany- Troy Hills heretofore adopted that are inconsistent with any of the terms and provisions of this Ordinance are hereby repealed to the extent of such inconsistency.

SECTION 4. This ordinance shall take effect immediately upon final passage and publication as provided by law.
