ORDINANCE NO. 2018:02

AN ORDINANCE OF THE TOWNSHIP COUNCIL OF THE TOWNSHIP OF PARSIPPANY-TROY HILLS, COUNTY OF MORRIS, STATE OF NEW JERSEY AMENDING AND SUPPLEMENTING CHAPTER 290, PARKS RECREATION AREAS AND PUBLIC LANDS, ARTICLE I, MOTOR VEHICLES; FEES, SECTION 290-4, KNOLL COUNTRY CLUB UTILITY FEES AND CHAPTER A445, FEES COMPILATION, SECTION A445-37, KNOLL COUNTRY CLUB UTILITY, OF THE CODE OF THE TOWNSHIP OF PARSIPPANY-TROY HILLS IN THE COUNTY OF MORRIS, NEW JERSEY

WHEREAS, the Township of Parsippany-Troy Hills (the "Township") wishes to update its Fees Compilation Ordinance regarding the Knoll Country Club Utility.

NOW, THEREFORE, BE IT ORDAINED by the Township Council of the Township of Parsippany-Troy Hills, Morris County, as follows:

SECTION 1. Chapter 290, Parks, Recreation Areas and Public Lands, Article I, Motor Vehicles; Fees, Section 290-4, Knoll Country Club Utility Fees, of the Township Code is hereby deleted in its entirety and replaced as follows:

A. Knoll West.

Nonrefundable Deposit: For those scheduling outings, a nonrefundable deposit of \$500 to reserve the date must be paid.

Exception to Nonrefundable Deposit: In the event a previously reserved outing is canceled by a nonprofit organization in enough time for another outing to be scheduled for the previously reserved date, thereby resulting in no loss of revenue to the Township, the deposit may be refunded to such nonprofit organization.

C. NOTES:

(1) For purposes of this fee schedule, an individual will be considered a Township Resident if their principal place of residence is located in Parsippany-Troy Hills and/or they own real property and the individual seeking the status of a Township Resident for this fee schedule is personally liable for real property taxes on same. A corporation shall be considered to be a Township Resident if the corporation owns or leases property in Parsippany-Troy Hills for the purpose of conducting a business. All applicants who seek resident status for purposes of the Knoll West Fee Schedule shall produce, at the request of the Township, such proof of residence as the Township may require.

(2) All Knoll West members pay Member rates at the Knoll East.

(3) Must provide proof of residence.

(4) 62 (Sixty-Two) years of age.

(5) Opening day to March 31 after 1:30 pm;
April 1 to October 31 after 3:30 pm;
November 1 to Closing after 1:00 pm

(6) For two golfers renting one cart, each golfer will be billed half of the cost of an 18-hole cart, plus tax. For one golfer renting one cart, that golfer will be billed half the cost of an 18-hole cart, plus tax.

- (7) For one golfer renting a cart for 9-holes, the cart rental will be billed half the 9-hole rate, plus tax.
- (8) Exemptions. The following individuals or groups are exempt from the payment of Knoll Country Club Utility fees:
 - (a) The members of the two high school golf teams and their two coaches (one per school) for practice and the opposing team and coach for matches, provided that practices and matches are played on weekdays.
 - (b) The Golf Superintendent, Golf Greens Superintendent and Golf Pro are exempt from Driving Range fees.
- (9) All Township employees and active volunteer members of the six fire districts, two volunteer ambulance squads, the rescue and recovery squad and the Office of Emergency Management shall pay the resident rate for greens fees and golf cart rental at both the East and West Courses.
- (10) Membership fees shall be prorated on or after July 1 to 50% of the annual fee for all new applicants.
- (11) The Golf Superintendent has the discretion to reduce daily greens fee rates with approval of the Certified Financial Officer. Backup documentation required for auditors.
- (12) Member dependent children and grandchildren under the age of 22 shall pay resident rates for all Greens Fees and Golf Cart Rental Fees at the West Course. Proof of age is required. Member is required to be present during golf play for dependent children and grandchildren.
- (13) Daily/Weekend after-hour times shall be as follows:

Opening Day through March 31 after 1:30 pm
April 1 through October 31 after 3:30 pm
November 1 to closing after 1:00 pm
- (14) All member accounts with a delinquent balance as of the last day of each month will incur a finance charge of 8% per annum.
- (15) All Knoll West memberships include unlimited golf balls at the driving range for the season.
- (16) All credit card transactions will incur a convenience fee of \$3.00.

SECTION 2. Chapter A445, Fees Compilation, Section A445-37, Knoll Country Club Utility, of the Township Code is hereby deleted in its entirety and replaced by the aforementioned Chapter 290, Parks, Recreation Areas and Public Lands, Article I, Motor Vehicles; Fees, Section 290-4, Knoll Country Club Utility Fees.

SECTION 3. To the extent that any previous ordinance or resolution is inconsistent herewith or contradictory hereto, said ordinance or resolution is hereby repealed or amended to the extent necessary to make it consistent herewith.

SECTION 4. If any part(s) of this ordinance shall be deemed invalid, such part(s) shall be severed and the invalidity thereby shall not affect the remaining parts of this ordinance.

SECTION 5. This Ordinance shall take effect upon passage and publication in accordance with applicable law.
